Local Section Bylaws Revision Process Update

Your Vote is Needed for Final Approval

We updated our 1977 bylaws through a three year process that included reviewing how other sections revised their bylaws, debating options when there were several ways to approach a revision, and working with the ACS Committee on Constitution and Bylaws. The Committee on C&B had a number of requests for review, and we had them review our initial changes a second time, as the bylaws were so old they required a lot of changes. Finally, we had them review a revised draft just to be sure we had made all the required changes. The Committee on C&B was enormously helpful in suggesting particular wording and alerting us to pending changes that ACS was making in their own constitution and bylaws. We feel very good that the draft we are making available to Section members for review and vote will be approved by ACS.

This fall you will be asked by national ACS to vote on a revised ACS constitution and bylaws. There is one section involving membership that will affect the wording of our bylaws. This section relates to changing the description of student members (currently student affiliates). In the bylaws voting materials on our web page there are two versions of a short paragraph related to student members — we will use the version that matches the ACS national vote. After our Section votes, and if approved, we submit the ballots and a description of our election process to ACS for final approval. We anticipate our voting will be final about the time the ACS voting is final, so the bylaws revision process is expected to be completed by late fall.

Voting for the bylaws revision will be combined with the normal fall voting for officers; you should receive a ballot in the mail in late October. A one page insert in this Newsletter summarizes the rationale for revising the bylaws, lists the significant changes, and reviews the overall process for making changes. Copies of the 1977 bylaws, a final draft of the new bylaws, and a marked up version (indicating the deletes and additions) is available on the Section website – http://sazacs.org (linked off the home page). Bylaws Revision of Southern Arizona Section, American Chemical Society FAQ List for Section Members

August 28, 2008

All ACS Southern Arizona Local Section members will be asked to vote on a revised set of bylaws this fall. The mailed ballot will include the bylaws vote as well as the vote for officers and Alternate Councilor.

The following documents are posted on our web site (http://sazacs.org): 1) this FAQ page, 2) the current Bylaws (1977 - 4 pages), 3) a marked up Bylaws version that shows all changes (8 pages), 4) and a final Bylaws version (7 pages). This revision of the Section Bylaws follows the format recommended by ACS and reflects comments by the ACS Committee on Constitution and Bylaws.

1. Why did we revise the bylaws?

The current bylaws were approved in 1977. Over the last 31 years the bylaws format and terminology suggested by ACS has changed and these changes affect local section operations. In addition, the old bylaws had some gaps due to changes in communications technology and lack of clarity for managing the local section.

- 2. What are the significant changes? (This is a summary, details are available on Section webpage).
- a. Revised the purpose of our Section to be consistent with ACS revised Constitution and our Section Long Range Plan (copy available on Section webpage).
- b. Redefined members and affiliate members to reflect changes in ACS Constitution and Bylaws
- c. Reworded, combined, added, or deleted several portions of bylaw sections. Overall five Bylaws were deleted and two Bylaws were added and most others were changed.
- d. Added reference to Section Operating Guidelines to allow for flexibility on types of standing committees; the operating guidelines can be revised by the Executive Committee as appropriate.
- e. Clarified and specified options for nominations, voting and details on providing meeting notices to reflect new types of communication.
- f. Added a section on recall of local section elected officials and included specific instructions for Section nominations and voting.
- g. Changed minimum number of meetings the section holds each year from 6 to 2 and the definition of Section meeting quorum from 25% to 2% of total membership. As a reference point the Section membership is about 560.

- 3. What is the process for changing the bylaws?
- a. The Executive Committee submits a draft of the Bylaws changes to the ACS. The Executive Committee consulted with ACS and reviewed the bylaws of 15 other sections, reviewed Robert's Rules of Order relative to bylaws, and held a number of lengthy discussions on what to change. The Section draft changes were reviewed by the ACS Committee on Constitution and Bylaws (C&B) and suggestions were made to the Section for revisions. We benefitted from recommendations by the ACS Committee on C&B and we followed the committee's "model for the preparation of bylaws for a local section". The final draft presented for your vote is unanimously supported by the Executive Committee.
- b. The next step is to share the draft with Section members, including appropriate notification in advance of a vote and an opportunity to review and discuss the draft with the Section leaders. The members vote by a written ballot. Our vote will be combined with the officers elections in late October. Following the vote, the Executive Committee forwards the vote results, the voting procedure, and the revised bylaws to the ACS Executive Director. The ACS Committee on C&B reviews the process and the vote result and either approves the bylaws or requests more changes. If there are additional changes, another vote by the membership is required.
- c. The membership will be notified by newsletter (paper and electronic), alerts in notices of Section meetings, announcement and handouts at fall Section meetings, and postings on the Section web site.
- 4. Where can I get additional information if I have questions?
- a. Go to the Section web site for copies of the current bylaws, draft bylaws, or a copy of the marked up version that includes additions and deletions. http://sazacs.org (bylaws are linked from the home page).
- b. Attend a meeting of the Executive Committee for more detailed discussion (Oct 7 at 5:30 at University of Arizona Chemistry Building see contact below for more information).
- c. If you do not have electronic access you can request a paper copy of the bylaws materials.
